Exhibitor/Vendor intends to use the booth for the following purpose:

- 1) Booth Fee is \$200.00 payable in advance by August 14 2010 along with signed agreement.
- 2) Booth size is 10 foot by 10 foot.
- 3) Booth assignment is based on when Exhibitor/Vendor signed request and payment are received.
- 4) Electric power (110 volt AC) is available for general exhibit use, to include small fans.
- 5) Exhibitor/Vendor provides all display materials, tables, chairs, UL approved power cords etc.
- 6) Set up day is Friday, September 3, 2010 from 1:00 p.m. to 5:00 p.m.
- 7) Exhibitor/Vendor will have access to the building each Fair day 1 hour prior to Fair opening time listed on the 2010 Schedule of Events.
- 8) The Commercial building is NOT air-conditioned – please dress accordingly.
- 9) No vehicles are allowed to be parked near the building except for unloading and loading for short periods of time.
- 10) Parking is available outside the Fairgrounds either in the free parking lots, or at pay lots.
- 11) All Exhibitors/Vendors must pay the gate entry fee each day. Passes are not available.

- 12) Bathroom facilities are available outside the building in various locations.
- 13) Booths may not be torn down prior to Saturday, September 11, 2010 at 8:00 p.m.
- 14) Exhibitor/Vendor is responsible for cleaning rented booth of trash and placing trash in the proper containers.
- 15) Both Exhibitor/Vendor and the White County Fair Association may post a link to each other's web-site on their own web-site.

Note: *The White County Fair Association Board reserves the right to revoke this agreement for conduct that does not reflect the views and purpose of the White County Agricultural Fair, or adherence to this booth rental agreement. Exhibitors/Vendors not adhering will be asked to leave the premises immediately and future participation will be denied. If an Exhibitor/Vendor is asked to leave, there will be no refund of any part of the booth rental fee. The White County Fair Association **will not** refund booth fee after the start of the Fair.*

Release and Indemnification of the White County Fair Association Board and Board Members:

White County Fair Association Board and Board Members shall not at any time or to any extent whatsoever, be liable and responsible or in any way accountable for any injury to or death of persons or loss, destruction or damage to property, including property and employees of undersigned, occurring on, or about the premises, or wherever occurring, resulting from any use of or activity on the premises, whether such injury, death, loss, destruction, or damage shall be caused by or in any way result from or arise out of an act, omission or negligence of undersigned or of any occupant, subtenant, visitor or use of any portion of the demised premises, or shall result from or be caused by any other matter or thing, whether of the same kind as, or of a different kind in the matters of things set forth, and undersigned shall forever indemnify the White County Fair Association Board and Board Members against any and all claims, liability, loss, damage, action or causes of action whatsoever on account of any such injury, death, loss, destruction or damage and any related expense, including attorneys fees. The undersigned further acknowledges that on the expiration of usage, the undersigned shall surrender the premises in good, sanitary, and neat order, condition and repair, Should any property on these premises be lost, damaged, or injured in any way whatsoever, the undersigned agrees to reimburse the White County Fair Association for all said loss, damage or injuries.
